The application fee paid will be forfeited as if the Exhibitor da cancelled the participation as of such date; or If the Exhibitor's display on its stand incorporates less than 60% of its display area exhibiting the appropriate products corresponding to the product category zone, if any, chosen by the Exhibitor on its application for allocation of Space a the Exhibition.

  - If the Organizers in their sole and absolute discretion decide that such right shall (q) be terminated.

In the event that an Exhibitor's right to exhibit in the Exhibition is terminated under 58(a), (b), (c), (d), (e), or (f), the exhibitor shall have no claim for refund of any monies paid against the Organizers. The Organizers shall return to the Exhibitor all rental paid in the event
